Multi-Sector Mission Toronto, Ontario June 5th - 9th, 2023

Innovation PEI will lead Multi-Sector Mission into Toronto, Ontario on June 5th - 9th, in support of trade and networking opportunities in this region.

Attendance on this mission will broadly advance provincial companies across Canada and North American jurisdictions and strengthen relationships between Island companies in the following sectors: Manufacturing, Information and Communications Technology, Professional Services, Seafood, Food and Beverage sectors. Each company will feature a custom B2B program to meet and support export objectives and feature export-ready products from across the Island, also in market transportation will be provided. Travel support of up to 40% is available, upon application prior to show, to exhibiting companies and those that choose to walk the show. The participation fee is \$500 per company. It will be a great opportunity to be back in the market of PEI companies since the pandemic and lockdown measures were in place.

- Travel cost support on economy airfare, accommodations and meals (40% by Innovation PEI).

Conditions for Participation:

Prince Edward Island companies must have the expertise and capacity to provide needed services and/or goods in the specific fields outlined. Companies must demonstrate that the products and/or services you seek to promote through the mission will result in significant economic benefit for Prince Edward Island (i.e. increased production in Canada, employment creation, technology transfer, increased research and development activity, etc.).

*You must be a PEI registered company to be eligible for this show.

If we are uncertain as to the economic benefit for Prince Edward Island of the company's activities, supplemental information may be requested to assess the company's suitability for participation.
